



## Conditions of Participation for the "Yamaha Pro Music Product Guide-App – Guitars" Sweepstakes

### 1. Object

- a) These Conditions of Participation regulate participation in the "Yamaha Pro Music Product Guide-App – Guitars" sweepstakes.
- b) This sweepstakes is put on by Yamaha Music Europe GmbH Siemensstrasse 22-34, 25462 Rellingen (hereinafter "Yamaha").
- c) By participating in the sweepstakes, all participants accept these conditions of participation and are bound to them upon entry into the competition.

### 2. Terms and Conditions of Participation

- a) The sweepstakes will run between 10:00 AM, CET on 13 April to 09:59 AM, CET on 20 April 2018 on the Yamaha Guitars Facebook page, available at <https://www.facebook.com/YamahaGuitarsOfficial/>. Answers received after this time will not be included in the competition.
- b) All persons residing in Germany, Great Britain, or France who are at least 18 years of age may participate in the sweepstakes.  
Yamaha employees and their family members, and all other persons associated with or helping with the sweepstakes in any manner are prohibited from participating.
- c) The following prizes will be given away among all participants:  
1st-2nd prizes: each one (1) Yamaha Revstar RS820CRRRT, including shipping costs.  
3rd-12th prizes: each one (1) Yamaha Guitar Tuner YTC5, including shipping costs.
- d) To take part in the sweepstakes, participants are required to like the Yamaha Guitars Official Facebook page, download the "Yamaha Pro Music Product Guide" app to their tablet, access the "All Products" page of the guide, and take a photo of themselves giving the "thumb's up" in front of the open page (see example photo), then upload this photo to the comments section of the posts.



- e) Twelve winners will be selected from all photos received. Only one submission is allowed per Facebook account. We will not accept any liability for lost answers or technical disruptions during transmission.

### 3. Rights of use, indemnification, and responsibility

- a) Yamaha is not obligated to review content provided by participants for possible violations of third-party rights. However, Yamaha is entitled to reject content if it is illegal or violates common decency under a proper assessment.
- b) Yamaha reserves the right to exclude participants from taking part in the sweepstakes. This applies in particular if they have violated the Conditions of Participation or use any dishonest aids. Yamaha may also exclude participants retroactively, deny prizes, or request that prizes be returned.
- c) By uploading content, participants declare that said content is free from third party rights, meaning that it is owned by them or that they have permission from the copyright holder of the content.
- d) Participants release Yamaha from all third party claims related to content provided by participants. They declare their willingness to support Yamaha in defending against such claims in every reasonable manner.

### 4. Sweepstakes process

- a) Winners will be notified via Facebook within seven (7) business days after the end of the sweepstakes and requested to provide a postal address in their country of residence. If Yamaha is not able to contact winners within fourteen (14) business days, or if potential winners do not respond within fourteen (14) business days or if they violate these Conditions of Participation, they will forfeit their prize and an alternative winner will be selected using the same selection process.
- b) Prizes will be sent within six (6) weeks after the end of the sweepstakes to the mailing address provided by the winner in their country of residence.
- c) Prizes may not be exchanged for cash, and no alternative prizes will be awarded. Prizes are not transferable or intended for resale. The participant may decide to waive their prize. In such cases, a new winner will be selected.

### 5. Guarantee exclusion

Yamaha hereby informs participants that it cannot guarantee the availability or function of the sweepstakes. The sweepstakes may be ended or removed due to external circumstances or forces, without this resulting in any claims by participants against the event organizer.

These may include technical problems, rule changes, or decisions by platforms such as Facebook.

### 6. Data protection

- a) This competition is not sponsored, supported, or administered in any manner by Facebook or other social networks.
- b) In order to complete and process the sweepstakes, Yamaha will collect the following personal data from winners:
  - Participant's name
  - Age
  - Mailing address

Participants hereby declare their agreement that Yamaha may collect this personal data for the purpose of administering and carrying out the competition and that Yamaha may disclose the winner's name on the Yamaha website and/or Yamaha social media channels.
